Made by the President under section 8a(2) of the Customs Act

THE COMMON EXTERNAL TARIFF (VARIATION OF DUTY) (NO. 4) ORDER, 2018

- 1. This Order may be cited as the Common External Tariff Citation (Variation of Duty) (No. 4) Order, 2018.
- 2. In this Order, where "Ex" is used in relation to an item number Interpretation under a heading listed in the First Column of the First Schedule to the Customs Act, that item number shall refer only to the corresponding goods described in the Second Column.
- 3. The rates of duty set out in the First Schedule to the Customs $v_{ariation\ of}$ Act, in relation to the goods carrying the headings and descriptions $v_{ariation\ of}$ duty in the listed below in the First and Second Columns respectively, are varied to $v_{Chap.\ 78:01}$ The amount specified in the Third Column for the period specified in the $v_{Chap.\ 78:01}$ Fourth Column—
